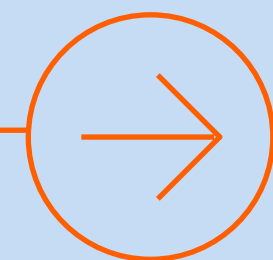
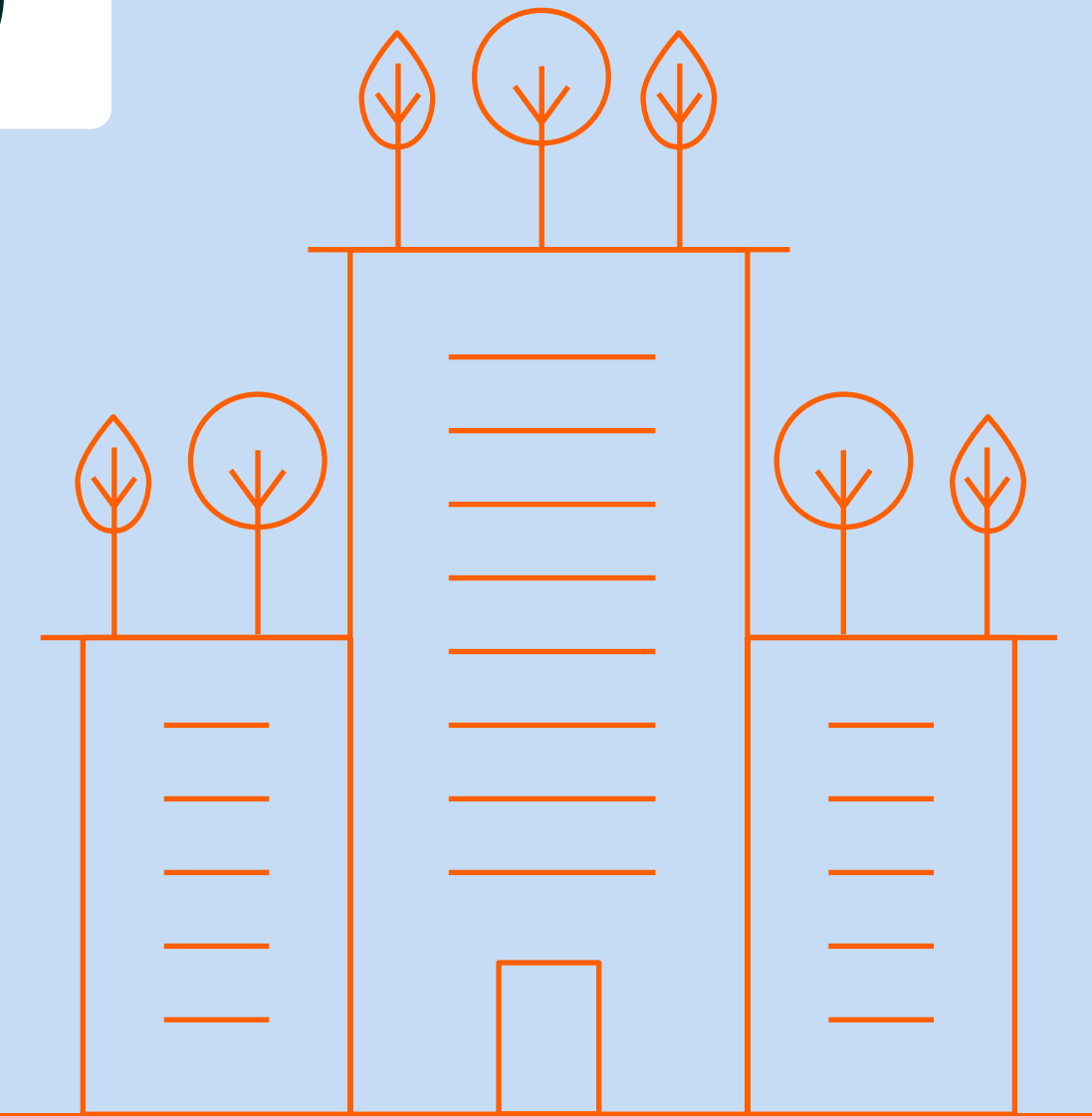

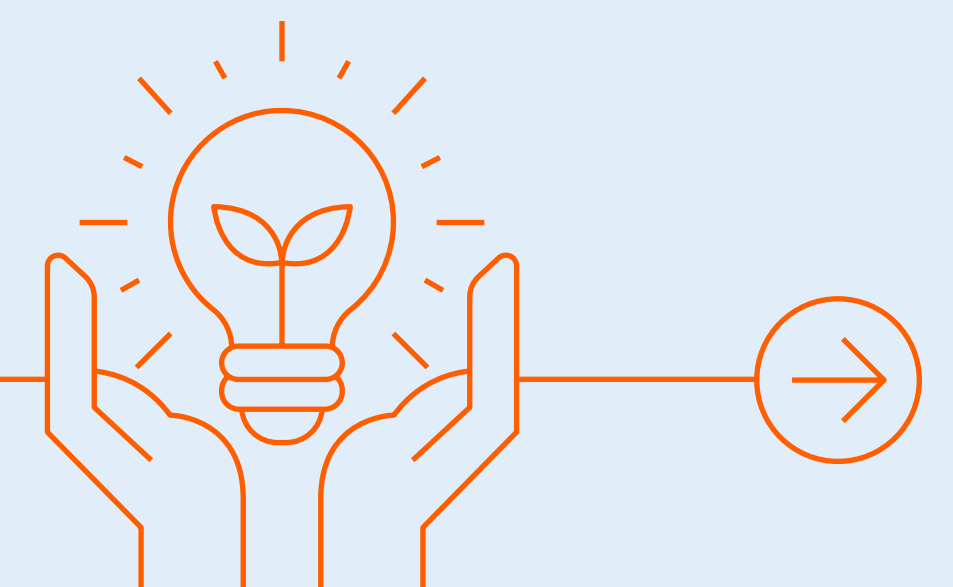
Streamlined Energy and Carbon Reporting (SECR) requires qualifying organisations to report energy and carbon data in their annual accounts.

On average, an organisation can reduce its annual energy costs by 20% by improving energy efficiency and management.

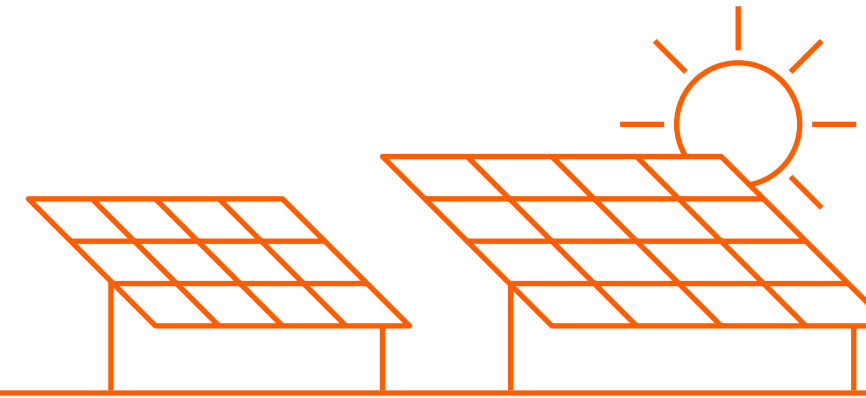

Who needs to comply with SECR?

SECR is a mandatory reporting requirement for large UK organisations that meet at least two of the following criteria within a reporting year:

A turnover of

£36 million+

A balance sheet of

£18 million+

Employees

250+

This applies to:

- Quoted companies
- Large unquoted companies
- Large Limited Liability Partnerships (LLPs)
- Certain charitable organisations and groups where reporting thresholds are met

What must be reported?

Organisations must disclose energy use and associated greenhouse gas emissions within their annual Directors' or Trustees' Report:

- Energy consumption (electricity, gas, transport fuel)
- Carbon emissions: Scope 1, Scope 2, and relevant Scope 3 (e.g. business travel)
- Intensity ratio(s)
- Methodology used
- Commentary on energy efficiency measures taken during the year

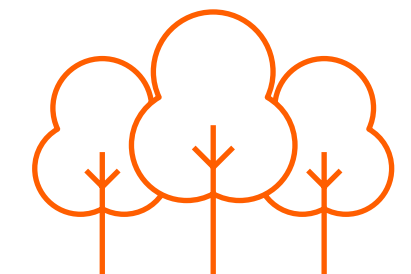

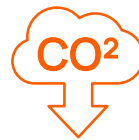

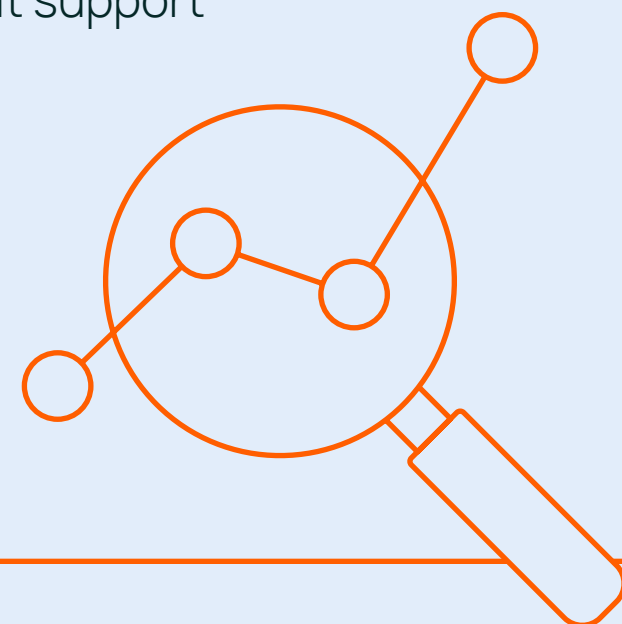
