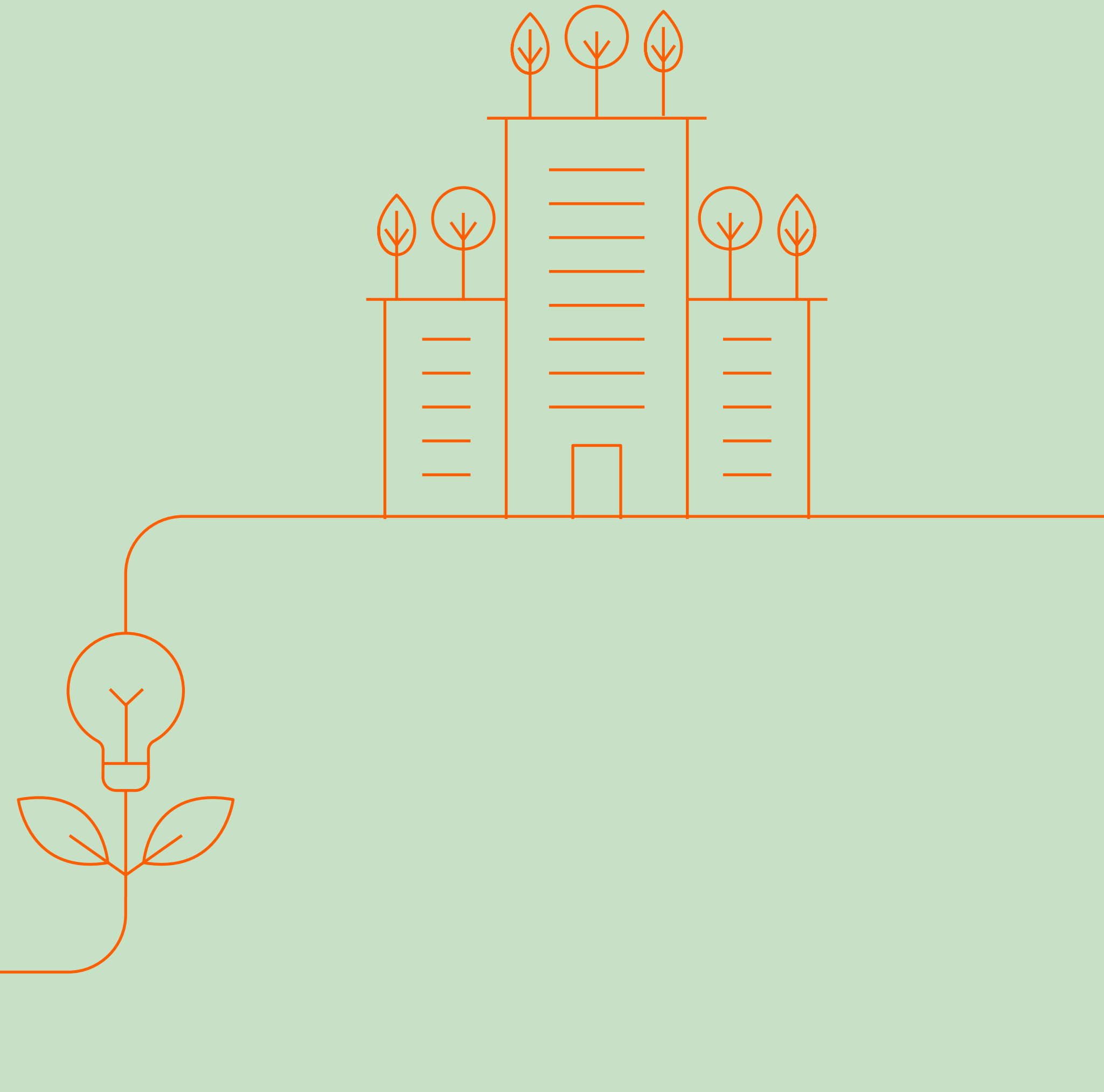

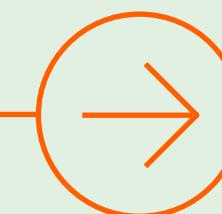

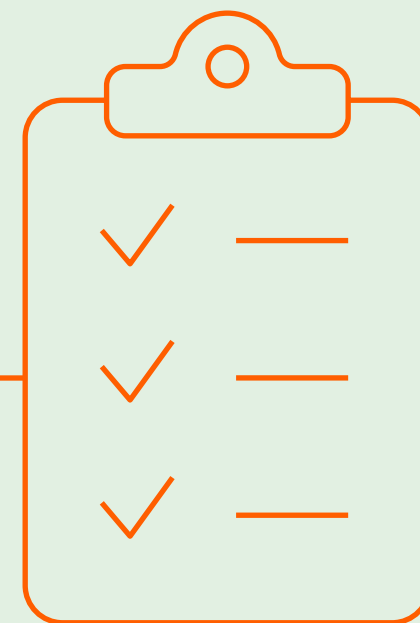
Getting started
